- ▶ Accidents travelling to and from shows and during the show
- ▶ Claims against you if your dog/s cause an accident, damage to property or are involved in a biting incident
- ▶ Claims against breeders and stud dog owners in the event of damage to stud dogs or bitches
- ▶ Claims against breeders by puppy owners should their puppy be defective
